DENTAL PLANS

Harvard's dental plan covers preventive, basic, restorative, major, and orthodontic services. Harvard offers dental benefits to eligible employees and dependents through <u>MetLife Dental</u>, which includes dentists in PDP Plus Network, a dental PPO. You can review the plan features below.

When you see a dentist in MetLife's PDP Plus network, there is no balance billing for in-network dentists; you cannot be billed for the difference between your dentist's rate and MetLife Dental's negotiated rate. Non-participating (out-of-network) dentists may balance bill. MetLife will reimburse up to the 99th percentile of reasonable and customary rates for non-participating dentists. You may be responsible for the difference if the provider bills above the 99th percentile.

Our innovative plan design gives you extra protection if you experience high costs that exceed the basic annual maximum of \$3,000. If you are enrolled in Delta Dental and you reach your Level 1 maximum of \$3,000 in eligible expenses in a calendar year, you will automatically receive Level 2 coverage, as described below.
