RETIREMENT PLANNING CHECKLIST

Planning and preparation are essential for a successful retirement. This two-page checklist provides tips and resources to consider as you think about your future.

Confirm your Harvard post-retirement health eligibility and visit <u>hr.harvard.edu/retiree-health</u> to use the Post-Retirement Health Calculator.
Contact the Harvard University Retirement Center (HURC) to get your pension estimate(s) if you are in the 1995 plan or if you were hired prior to 7/1/2001 and have a Basic Account in the Staff Plan.
Review your Social Security benefits at <u>ssa.gov</u> .
Review the <u>What Happens When You Retire from Harvard</u> overview.
Attend a retirement planning workshop on topics including Harvard benefits, Social Security benefits, Medicare, retirement income planning, estate planning, and strategizing your next chapter.
Review your financial portfolio and consider scheduling a consultation with a TIAA advisor, where you can discuss your post-retirement budget, income replacement, changes to asset allocation, and how to manage required minimum distributions.
Consider increasing your TDA contributions; visit <u>hr.harvard.edu/employee-funded-retirement-programs</u> .

Review your benefit options in retirement by visiting <u>hr.harvard.edu/retiree-health</u>.

Contact former employers for information about any retirement benefits you may be eligible to receive.
